# Information for the data subject in accordance with Article 13 GDPR

We, media:net berlinbrandenburg e.V., Ackerstraße 3a, 10115 Berlin (hereinafter 'media:net', 'we') as the controller are pleased to provide you with this information regarding the processing of your personal data (hereinafter simply referred to as 'data') in accordance with Article 13 of the EU General Data Protection Regulation (GDPR). For all data processing, we adhere to the General Data Protection Regulation (GDPR) and Germany's Federal Data Protection Act (BDSG).

## Purposes of processing

We process data for the purposes defined in media:net's Articles of Association, the coordination and promotion of media and creative industries in Berlin-Brandenburg, attracting companies and entrepreneurs to the area, promoting young companies and further training and education. To do so, we connect companies and individuals in these industries, their service providers and industry users, as well as individuals and institutions from the fields of politics, business, education, science and research (see Article 2(1) of our Articles of Association). Among other things, membership provides members with access to business contacts, cooperation partners and professionals, to contacts in politics and funding institutions and representatives from other industries, as well as other networking events that enable exchange between our members. In order to manage membership, the member (company)'s name and address are processed. The contact person's first name, surname, address, email address, role and telephone number are also processed. In order to manage contribution payments, bank details may be processed.

The legal basis for this processing is Article 6(1)(b) GDPR. The data is in general only accessible by media:net employees. Only a public contact, separately named by you, will be published on our website under the 'Members' category, together with your company profile, for other members and member companies to see. This is to enable straightforward contact between members and promote networking and the development of business relationships.

You must provide the information requested in the application to become a member. We cannot process the membership application if this information is not provided.

### **Duration of processing**

We will only process your data for as long as you are a member, or for as long as is required or permitted by law.

### Your rights as a data subject

According to the GDPR, you have the right to:

- Access information about the processing of your data (Art. 15 GDPR)
- Rectification (Art. 16 GDPR) or erasure of your data (Art. 17 GDPR)
- Restriction of processing (Art. 18 GDPR)
- Data portability (Art. 20 GDPR)
- Lodge a complaint with a supervisory authority (Art. 77 GDPR)
